Pursuant to notice made to the newspaper of general circulation throughout Grant County, the radio station, county website, and e-mail distribution list, a regular meeting of the County Court was held at the County Courthouse in Canyon City, OR.

9:03 am -- Present Judge Myers was present via live-stream, Commissioner Hamsher, Commissioner Rowell, Administrative Assistant Laurie Stinnett, Road Department Office Manager Tammy Workman, Reporter Neil Nisperos. A Pledge of Allegiance was given to the United States Flag.

ORDER 2023-03. The County Court declared the Grant County Road Service District to be formed, following the process defined by ORS chapter 451. The final hearing on formation of the Road District was held at 9:05 a.m. on the 4th day of May, 2023 at the Grant County Courthouse in Canyon City. The Court then declared that 1) the Grant County Road Service District is hereby formed, 2) for the purpose of constructing, operating and maintaining all county roads in Grant County, Oregon, 3) that the boundaries of the Grant County Road Service District shall conform to the boundaries of unincorporated Grant County as described in Exhibits A, B and C as attached to Order 2023-01 and -02, and 4) the Grant County Road Service District's service territory includes all of the unincorporated lands within Grant County, Oregon. *MSP: Hamsher/Rowell – to approve Order 2023-03 to declare the Grant County Road Service District formed. Ayes- Hamsher, Rowell, Myers.*
