**ORDER 2023-01**

THIS BEING the 1<sup>st</sup> day of March, 2023 and a day set aside for a regular meeting of the Grant County Court and there being present Scott Myers, County Judge; Jim Hamsher, County Commissioner and John Rowell, County Commissioner; and

WHEREAS, the Oregon Revised Statutes (“ORS”) chapter 451 provides that a County may form a service district for the purpose of constructing, operating and maintaining public roads; and

WHEREAS, ORS 451.435 requires that service district formation shall be initiated, conducted and completed as provided by the District Boundary Procedure Act, ORS 198.705 to 198.955; and

WHEREAS, the County Court may initiate district formation by entering an order complying with the requirements of ORS 198.835; and

WHEREAS, as amended by HB 2174, ORS 294.060(8)(b) allows the County Court to request that the monies received under ORS 293.560 which would ordinarily be divided to the county road fund be credited instead to a road service district formed under ORS chapter 451, provided that the monies are used in the same manner and subject to the same restrictions as are applicable to monies in a county road fund, and the service district’s territory includes the entire county;

NOW, THEREFORE, THE GRANT COUNTY COURT HEREBY DECLARES AND ORDERS:

1. The County Court for Grant County (“Court”) intends to form a service district under ORS chapter 451.
2. The district shall be known as the **Grant County Road Service District** (“the Road District”).
3. The Court proposes to form the Road District for the purpose of constructing, operating and maintaining **all county roads** in unincorporated Grant County, Oregon.
4. The boundaries of the Grant County Road Service District shall conform to the boundaries of unincorporated Grant County, Oregon, as described in **Exhibits A, B and C**, attached.
5. The Road District’s service territory shall include all of the unincorporated lands within Grant County, Oregon.


6. A hearing on the Court's district formation proposal shall be held at **9:05 a.m.** on the **5<sup>th</sup>** day of **April, 2023**, at the **courtroom** of the **Grant County Courthouse**.

7. The County Clerk is hereby ordered to give notice of the hearing as required under ORS 198.840, 198.800 and ORS 198.730(2)-(3).


8. Any and all interested persons may appear and present written statements in favor of or against formation of the proposed Road District. A copy of the written statement must be submitted to the County Court on or before the date of the hearing in order for the statement to be considered. Any statement not made and filed as required under ORS 198.735 shall be considered voluntarily waived.

**IT IS SO ORDERED.**


